

Live Cover Breeding Contract For : Cool Son Ofa Gun AQHA # 5023571

**BOOKING FEE:** \$250.00 Non Refundable. **SERVICE FEE:** \$1,000.00 is to be paid in full at the time when the mare is picked up after she is bred. (Booking fee included in Service fee)

**MARE CARE:** Dry: \$10.00 per day, Wet: \$15.00 per day. Must be paid when mare is picked up.

**MARE OWNER:** Must show proof that the mare has had current vaccinations, worming, and is sound breeding condition, free from infectious or contagious or transmissible disease. The mare owner understands that the barren mare must have a clean uterine culture prior to breeding. Breeder reserves the right to refuse mare if not in satisfactory condition. **A copy of the mare's registration papers.**

**LIABILITY:** Liability of the mare and/or foal remains with the owner throughout the stay on the breeders place. ( Veterinarian cost, etc.)

**LIVE FOAL GUARANTEE:** It is agreed that a live foal is guaranteed from this mating. Should the foal not stand and suck, the mare owner will be entitled to return privileges the following breeding season with no service fee charge, but will be charged for mare care. Cooper Quarter Horses, LLC stallion owner will not be liable for any infectious, transmissible or inheritable diseases or conditions to the foal resulting from this breeding. The breeding fee that has been paid is not returnable and the return service is not transferable to another party. Upon the loss of a foal, the stallion owner must be notified with in one week from death. This notice must be accompanied by a statement from a licensed Veterinarian. It is further agreed that should the above stallion die or become unfit for service during this season or the season immediately following the one in which the original breeding fee has been paid and the mare does not have a live foal, the breeding fee will be returned as long as the mare owner is entitled to a return privileges as stated above. If the mare dies or becomes unfit to breed, another mare maybe substituted with the stallion owner's consent. If the mare comes back into heat after the first breeding, bring the mare back for a rebreed. If the mare does not take by the second time, the mare should be check by a Veterinarian.

I agree to feed and care for the mare and/or foal in a careful and proper manner, just as I would my own horses, and also agree to keep the mare owner informed as to any complication that may occur.
