2024 Stallion Service Contract ~ **Stallion Auction Breeding**

The breeding fee is **\$0.00/Mare**, which includes a **nonrefundable booking fee of \$0.00/Mare**. The booking fee is due upon signing of this contract. The remainder of the Breeding Fee, \$0.00, is due prior to breeding the above aforementioned mares in 2024. Breeding Fee is for one live foal. Each FedEx shipment will be charged a Chute/Shipping Fee of \$450.00.

This breeding contract is to be returned with the non-refundable Booking Fee \$0.00 and a copy of the aforementioned Mare's registration papers. This contract, with accompanying documentation and payment, must be completed and signed in order for your breeding space to be reserved for the year of booking (2024). Breeding methods currently available to GSR Rein N Bullets:

- 1) Pick Up Cooled Semen
- 2) Shipped Cooled Semen

**Shipped Cooled Semen**

- 1) Each FedEx shipment will be charged a Chute/Shipping Fee of \$450.00.
- 2) Stallions are collected Monday, Wednesday and Friday. There are no exceptions. It will be the responsibility of the Mare Owner and his/her veterinarian to confirm our collection days.
- 3) Semen must be ordered by 7:00 PM MST the day prior to shipment.
  - a. In the event that there is insufficient semen on a particular day, semen will be shipped on a first ordered, first served basis.
- 4) Semen requests can be made by phone or text: 208-320-1805, we do not accept Facebook Messages, fax, email, or anything other type of request as a method of ordering semen.
- 5) Cancellations must be made by 8:00 am MST the day of Shipment.
  - a. Cancellations made after this time will be subject to a \$50.00 Cancellation Fee.
- 6) All Fees must be paid, in full, prior to any shipment of semen.
- 7) Overnight shipments are sent as FedEx or UPS Standard Overnight. Semen can be sent as First Overnight at an additional charge.
  - a. We are unable to offer counter-to-counter shipping at this point in time and apologize for the inconvenience.
- 8) Mare Owners requesting shipped semen should expect to receive one dose of semen. Two doses will be shipped if available.
- 9) Shipping Containers must be returned in a timely manner. If a container is not returned within one week of shipment, a \$50.00 Fee will be billed and is payable by the Mare Owner.

Jackson Performance Horses, LLC, only assumes responsibility to ship semen in viable condition and shall not be held liable for contamination of semen during and after shipment, loss of viability, or any costs arising from shipments delayed, damaged or lost in transit.



**Mare Owner Responsibilities and Contract Details**

- 1) Mare Owner agrees to use all cooled semen provided by this Agreement for only the mare named in this Agreement and no other.
- 2) It is the Mare Owner's responsibility to notify Jackson Performance Horses, LLC of the pregnancy status of the mare post artificial insemination.
- 3) To obtain a Breeder's Certificate, you must notify Jackson Performance Horses, LLC, of the birth of the foal. This certificate will not be issued, nor released, until the account has been paid in full.
- 4) Embryo Transfers: Mare Owner agrees to notify Jackson Performance Horses, LLC, that this is an embryo transfer mare. In the event of multiple embryos from a single flush, Mare Owner agrees to notify Jackson Performance Horses, LLC, once the additional recipient mares have been confirmed in foal with a heartbeat present. The Mare Owner must then pay a Stallion Fee, equal to the aforementioned Stallion Fee, for each additional live foal. Additional Breeding Certificates will be issued upon receipt of necessary stallion fee(s).
- 5) Live Foal Guarantee: A live foal is described as a new born foal that stands and nurses without assistance.
  - a. It is understood that if the mare proves barren, aborts her foal, or if foal is born stillborn, a return breeding will be guaranteed the following year, 2025, providing that proper notification is received within 7 days of the occurrence.
  - b. LFG does not apply to mares exposed to or with complications due to nutritional neglect, i.e. fescue, blister beetles, mustard weed, etc.
  - c. Rebreds are subject to a \$450.00 Chute/Shipping Fee to be paid prior to any shipments the following year, 2025.
  - d. The LFG in this contract is non-transferable, should the Mare be sold or otherwise disposed of prior to the birth of the foal, the LFG granted shall be void. However, the Stallion Manager may, at his or her discretion, upon application and payment of a new Booking fee, continue to honor the live foal guarantee granted to the original owner. In the event that the Stallion Owner agrees to the transfer or assignment of the live foal guarantee rights under the terms of this contract, the new owner then agrees to be bound by all terms and conditions hereof, insofar as the same may be applicable.
  - e. Stallion Owner has not made and does not make any warranty or representation as to the quality or conformation of the foal, merchantability or fitness for a particular purpose, or that the foal will be free of any infirmity, conformation defect, disease or inherited trait. The Stallion Owner makes no implied warranties of merchant ability or fitness for a particular purpose.
- 6) Rebreeds: If the mare does not produce a live foal in the first breeding season, the Mare Owner is entitled to a rebreed the following year, 2025. Mare Owner will be subject to a Chute/ Shipping Fee of \$450.00 for each shipment sent. If the Mare Owner fails to return the mare for breeding the following year, then any and all fees paid shall be forfeited, the right to rebreed is cancelled and the Stallion Owner is released from all further obligation of the contract, unless otherwise agreed to in writing and signed by all parties.
- 7) Donated Breedings: All donated breeding's are subject to a Chute/ Shipping Fee of \$450.00 for each shipment sent.
- 8) This contract is valid for the 2024 breeding season only. Mare Owners may not purchase this contract with the intent to use in a subsequent season. In the event of this contract being paid in full, and the mare never being bred, this shall become a rebreed for the following season.
- 9) This contract is a binding agreement between Jackson Performance Horses, LLC, Stallion Owner and Mare Owner and is non-transferable unless otherwise agreed to, stated in writing, and signed by all parties.
- 10) The Mare Owner agrees that the mare presented for breeding will be in good health and in sound breeding condition. Any mare certified by the attending veterinarian to not be in sound breeding condition shall not be bred and a mare may be substituted at no additional charge.
- 11) Should the above named Stallion die or become unfit for service for any reason, or if the Mare should die or become unfit to breed, then this contract shall become null and void and both parties are relieved of any further obligation hereunder. Any monies paid by the Mare Owner toward the Stallion Fee, with exception of the non-refundable Booking Fee, shall be refunded at the discretion of the Stallion Manager.

Jackson Performance Horses, LLC, agrees to ship cooled semen as described above. If the mare fails to settle for any reason, the Mare Owner will not hold Jackson Performance Horses, LLC, responsible or liable for damages to the semen or condition of the Mare.

The undersigned agrees that the Stallion Owner, Jackson Performance Horses, LLC, Manager and its agents, officers and employees will not be responsible for accident, injury sickness or death to the mare or its foal; whether from fire, flood, theft, act of God, negligence by the Stallion Owner, Manager or any of its agents, officers or employees, or for any other reason. The undersigned agrees to and shall indemnify and hold harmless the Stallion Owner, Manager, its officers, agents and employees from and against any and all claims, losses, damages, causes of action, suits, and liability of every kind, including all expenses of litigation, court costs, and attorney fees for injury to or death of the mare or its foal, or for any damage to the mare or its foal arising out of or in connection with the services performed by the stallion manager under this contract, regardless of whether such injuries, death or damages are cause in whole or in part out of negligence of the Stallion Owner, manager, its officers, agents or employees.

The parties acknowledge that this agreement is made and shall be entirely performed within the State where the Stallion Owners facility is located and shall be construed and enforced under the laws of said State.

This contract is a binding agreement between Jackson Performance Horses, LLC, Stallion Owner and Mare Owner and is non-transferable unless otherwise agreed to, stated in writing and signed by all parties. Any transferred breeding's will incur an additional Booking Fee and completed paperwork by the new contract holder.
