This certifies _____, herein referred to as Mare Owner/Agent, has engaged a breeding service to the stallion **ROLL YOUR NICKLES AQHA# 5881867**, herein referred to as Stallion, for the mare _____ Registration # _____, herein referred to as Mare, for the 2023 breeding season. The Mare Owner/Agent agrees to pay a breeding fee of **\$500** (listed below all details):

- Stallion Fee \$ _1,000_____ (X)Stallion Auction _____
- **Booking/Chute Fee \$ 500 NON-REFUNDABLE (payable upon execution of this contract)**

Any deviation from these terms must be specified in writing and signed by CARDINAL HILL TRAINING CENTER, LLC, herein referred to as CRH, LLC, authorized representative. **The balance of the entire breeding fee is due prior to first shipment of semen**, no exceptions. The following conditions of service (for which there will be no exceptions) are mutually agreed between the Mare Owner/Agent, named above, and CRH, LLC, as owner of the above Stallion, upon the execution of this contract:

Pre-Breeding Arrangements (please provide each item listed below):

- Signed and completed contract
- A photocopy of your mare's registration papers
- Payment of stallion and chute fees and/or Rebreed fees
- Credit card authorization form for remaining fees and/or shipping fees

The breeding is NOT considered SOLD unless the total breeding fee has been paid.

Any incomplete registration certification or unpaid charges will result in a hold being placed on the mare's name on the appropriate stallion breeding report.

Unless shipping has been prepaid in conjunction with the contract, it WILL NOT be shipped without a current credit card authorization form on file. Credit card payments are subject to a 5% processing fee.

This contract is valid for the 2023 breeding season only. CRH, LLC breeding season begins *February 1st, 2023* and ends *June 30th, 2023*.

Frozen and/or cooled semen will ONLY be shipped during these dates unless previously approved in writing by CRH, LLC.

Breeding Arrangements:

- Our collection days are: MONDAYS, WEDNESDAYS, FRIDAYS
- Mare Owner/Agent must give a minimum of 24-hours advance notice of possible semen shipment to CRH, LLC and CONFIRM shipment by 8:00 AM CST of collection day prior to actual shipment. **ORDERS OF SEMEN MUST BE DONE CALLING OR TEXT CARDINAL STALLION STATION +1 (940) 305 3275. Cancellations must be made by 8AM CST the day of the shipment. Cancellations after the 8AM CST the day of shipment timeframe, will be subject to \$150.00 cancellation fee.**
- If Mare is to be brought on to CRH, LLC premises she must be in healthy and sound condition, having a current coggins certificate not older than 6 months and a list of all worming and vaccinations received in the last year. CRH, LLC, reserves the right to worm and vaccinate all mares coming to CRH, LLC property (4100 Reining Road – Aubrey TX 76227 where ROLL YOUR NICKLES is standing), with Strangles (Strep), Salmonella, E.W.T. and West Nile, at the discretion of CRH, LLC. Mare Owner/Agent hereby hold harmless and indemnify CRH, LLC and employees for the administration of said vaccines. Additionally, Mare Owner/Agent hereby agrees to reimburse CRH, LLC for any costs associated with the administration of said vaccines immediately upon receipt of said invoice.
- Every effort will be made to accommodate Mare Owner/Agent's breeding time frame. However, it is the Mare Owner/Agent's responsibility to ensure that CRH, LLC always up to date information throughout the process. In doing so, you are facilitating the insemination process. Failure to adhere to these arrangements may result in missed estrus cycles and delayed shipments (where applicable) at the Mare Owner/Agent's expense. A veterinarian knowledgeable in successful insemination techniques must oversee off site inseminations to maximize the potential of a timely pregnancy.
- Mare Owner/Agent agrees to have the mare checked for pregnancy by licensed veterinarian and provide the results of the ultrasound(s)/pregnancy exam(s) to CRH, LLC within 30 days of insemination to **MAINTAIN LIVE FOAL GUARANTEE.**
- **LIVE FOAL GUARANTEE/REBREED PRIVILEGES.** A live foal is defined as a newborn foal that stands and nurses without assistance within 24-hour of birth. The Live Foal Guarantee shall apply ONLY TO THE NEXT NORMAL BREEDING SEASON. If Mare miscarries, aborts the foal, or the foal does not qualify as a "live foal" and CRH, LLC is provided with a veterinarian's statement confirming such conditions, Mare will be qualified for a Live Foal Guarantee/Rebreed Privileges the following breeding season. To obtain a breeding the following season using this policy, Mare Owner/Agent must request, complete, and return a **Rebreed Contract and pay a \$500.00 rebreed fee.** In the current contract year, should Mare never be deemed "in foal" following insemination, Mare is eligible for a rebreed the following year with a completed **Rebreed Contract and a \$500.00 rebreed fee.** Live Foal Guarantee/Rebreed Privileges

shall only apply if CRH, LLC is notified within seven (7) days of Live Foal Guarantee/Rebreed event. If Mare does not return to a veterinarian the following breeding season for Live Foal Guarantee/Rebreed Privileges and other arrangements have not been made with CRH, LLC, all fees paid shall be forfeited, the right to a Live Foal Guarantee/Rebreed will be cancelled, and CRH, LLC is released from all further obligations under this contract.

- If Mare dies, or is deemed unfit to breed, during the breeding season (a veterinarian report will be required as verification) a substitute mare, owned by the same Owner, and approved by the CRH, LLC, may be bred without any additional fee. Substitutions and/or switching of mares owned by the same Owner for any other reason (after a booking has been accepted and booking fee paid) **will be subject to a \$200 transfer fee.** Transfers of fully paid breeding contracts, to an Owner other than the person stated on the contract, **will be subject to a \$200 transfer fee.**
- Stallion 5 panel test results: HERDA N/N, PSSM N/N, GBED N/N, HYPP N/N and IMM N/N
- **The price paid for this contract is for a single foal. Additional foals/vitrified embryos obtained from the semen provided from the current contract year (whether from embryo transfer, intracytoplasmic sperm injection – “ICSI”, double ovulation, etc.) are required to pay additional regularly priced 2023 stallion fee for each additional foal/vitrified embryo.**

Transported semen. There will be a limited number of shipped semen contracts. Mare may be sent to CRH, LLC for breeding or kept at a facility in the area. If kept at a facility in the area, Mare may be brought to CRH, LLC for insemination. Semen may also be picked up by a representative of the facility where Mare is being kept. Mare bred with shipped semen will be subject to the shipping charges (see **Shipment Information and Additional Charges**).

Shipment Information and Additional Charges:

It is the Mare Owner/Agents responsibility to order a shipment at least 24-hours in advance!

- Cooled semen can be shipped via Federal Express (next day arrival) at a rate of **\$300 per shipment (US only) / \$550 (Canada – frozen semen \$1,200).**
- Counter to counter airline shipments (same day arrival) are available at a rate of **\$400 per shipment.** Availability of airline shipment depends on air cargo routes operated by airlines contracted with CRH, LLC.
- If Federal Express/UPS delivery is unavailable within a 24-hour period, additional notice will be required. Mare Owner/Agent should check with Federal Express/UPS for weekend delivery, holiday delivery or customer pickup.
- CRH, LLC shall not be responsible for **COSTS** arising from shipments lost, damaged, or delayed in transit. CRH, LLC shall take every reasonable precaution to ensure that the semen is protected during shipment. However, neither CRH, LLC or their employees control the shipment once it leaves their custody and therefore shall not be responsible for the condition of cooled shipped semen received by Mare Owner/Agent.
- Mare Owner/Agent must specify shipment method, Federal Express or airline counter-to-counter service, when ordering semen. For counter-to-counter, Mare Owner/Agent must provide the name of the destination airport (the airport to which the shipment is to be sent).
- It is the Mare Owner/Agent's responsibility to return a copy of the INSEMINATION CERTIFICATE, signed by administering Veterinarian or Breeding Facility Manager, to CRH, LLC and to forward a signed copy of the certificate to the appropriate Breed Registry. Mare Owner/Agent is also responsible for blood typing or DNA testing their mare as per AQHA rule #209 or APHA rule RG-165.
- Semen that is picked up for insemination and same day removal will have a charge of **\$100** payable at the time of collection/service. If Mare is brought at CRH, LLC for artificial insemination the Mare Owner/Agent will be charged a haul-in fee of **\$30.**
- The Mare Owner/Agent is aware the Stallion might still be shown during breeding season; in case cooled semen is UNAVAILABLE, frozen semen will be shipped instead at a rate of **\$550 (US ONLY) / \$1,200 (Canada)**
- If a second foal is conceived, with the same mare on this contract or another one, with the same dose of cooled semen shipped or a leftover dose of frozen semen, a registration application will be provided only after payment a regularly price 2023 Stallion fee at the time the breeder informs CRH, LLC.
- A **\$200** late fee will be charged to the breeder if pregnancy communication is made after 11/30 of the breeding year of Mare.
- **The price paid for this contract is for a single foal. Additional foals/vitrified embryos obtained from the semen provided from the current contract year (whether from embryo transfer, intracytoplasmic sperm injection – “ICSI”, double ovulation, etc.) are required to pay additional regularly priced 2023 stallion fee for each additional foal/vitrified embryo.**

The undersigned agrees that the breeder and its agents, CRH, LLC and employees will not be responsible for accident, injury, sickness, or death to the mare or its foal; whether from fire, flood, theft, act of God, negligence by the breeder or any of its agents or employees, or for any other reason. The undersigned agrees to and shall indemnify and hold harmless the breeder and its agents, CRH, LLC and employees from and against any and all claims, losses, damages, causes of action, suits, and liability of every kind. This includes all expenses of litigation, court costs and attorney's fees, for injury to or death of Mare or its foal arising out or in connection with the services performed by the breeder under this contract, regardless of whether such injuries or death are caused in whole or in part out of negligence of the breeder or its agents or CRH, LLC or employees.





ROLL YOUR NICKLES

The parties further agree that should the Stallion die or become unfit for breeding purposes, this contract shall become null, and void and any money paid on the stallion fee, except the NON-REFUNDABLE booking/chute fees, shall be refunded to the Mare Owner/Agent. When signed, by both parties, this document will become a legally and enforceable contract binding both parties. The parties acknowledge that this agreement is made and shall be considered entirely performed within the State of Texas and shall be construed and enforced under the laws of the State of Texas Law (Chapter 87, civil practice, and remedies code), an equine professional is not liable for any injury or death of a participant in equine activities resulting from the inherent risk of equine activities.
