TERMS AND CONDITIONS OF BREEDING CONTRACT

This agreement is made between Laughing Horse Ranch (hereinafter referred to as the stallion owner), and the owner of the mare described above and is subject to the following terms and conditions.

- 1. A \$350 non-refundable booking fee is due and payable upon execution of this agreement. Booking fee is included in the breeding fee. Only one breeders certificate will be issued per paid breeding fee. Shipped semen contracts the balance of the breeding fee is due prior to ordering semen. For breeding at Laughing Horse Ranch the balance of the breeding fee is due and payable before the mare departs from the ranch.
- 2. Any unpaid fees owed to Laughing Horse Ranch will be billed with a monthly interest rate of 1.5%. Breeders certificate will be issued when all fees are paid for in full and stallion owner is notified of a live foal
- 3. In the event the above mare fails to produce a live foal from the breeding privilege granted herein, or the foal produced from this breeding fails to live until January 1st of it's yearling year, mare owner may rebreed the mare (or a substitute mare mutually agreed upon by mare and stallion owners) during the following breeding season only. This guarantee applies only if the mare owner (A) notifies the stallion owner within 72 hours after the time the mare did not produce a live foal, or foal dies; and (B) within 10 days after the mare owners notice, the mare owner provides the stallion owner with a statement from a licensed veterinarian substantiating same. A farm fee of \$250 (includes first semen shipment) + \$100 Booking fee is due on all re-breeds. Breeding fee will not be refunded.
- 4. If the mare owner fails to contact the stallion owner for a rebreed the year immediately following, then any and all fees paid shall be forfeited; the right to a rebreed is cancelled and this contract is thereby terminated.
- 5. Mare owners agree to have mare ultra-sounded 14 17 days after the last date of insemination and notify stallion owner of pregnancy status.
- 6. Mare owners may not assign this breeding contract or substitute any other mare under this agreement without the prior written consent of the stallion owner. Any attempted assignment without prior consent of stallion owner will, at the option of stallion owner, terminate this agreement and release stallion owner from all obligations hereunder.

- 7. It is understood that if the above stallion dies or becomes unfit for service, this contract shall become null and void and the breeding fee less the booking fee shall be refunded to the mare owner.
- 8. Embryo transfers: Mare owner agrees to notify stallion owner that this is an embryo transfer breeding. In the event multiple viable embryos are produced from a single flush, the mare owner agrees to pay an additional breeding fee for each additional live foal.
- 9. By signing this contract, the mare owner certifies that he/she is the sole owner of the above-mentioned mare, or has authority to enter into this contract on behalf of the owner.
- 10. A photocopy of the mare's registration papers must be furnished with this contract.

The undersigned agrees that Laughing Horse Ranch and its staff will not be responsible for accident, injury, sickness, or death to the mare/foal whether from fire, flood, theft, act of God, or negligence by Laughing Horse Ranch or its staff. The undersigned agrees to and shall indemnify and hold harmless Laughing Horse Ranch and its staff from and against any and all claims, losses, damages, causes of actions, suits and liability of any kind including expenses of litigation, court costs, and attorney fees, for injury to, or the death of the mare/foal, or for any damage to the mare/foal arising out of, or in connection with, the services performed by Laughing Horse Ranch and its staff under this contract, regardless of whether such injuries, death or damages are caused in whole or in part out of negligence of Laughing Horse Ranch and its staff. Facebook Messages will not suffice. Mare owners understand that in the event that he is away from the breeding farm owner may be required to ship and utilize FROZEN SEMEN or that fresh semen will not be available at any given time during the show season. Laughing Horse Ranch strongly encourages mare owners to utilize reproductive management that has experience breeding with frozen semen in the event that fresh cooled semen is unavailable. 2024 Breeding Contract: On Farm Breeding Addendum

- 1. Jarvis Anderson Performance Horses will exercise best judgement in care and supervision of the mare/foal. The attending veterinarian will examine the mare for normal breeding conditions and will administer medical care as deemed necessary for the health and safety of the mare/foal. The mare owner hereby consents to all medical care administered to the mare by the stallion manager's veterinarian. The mare owner will pay all veterinarian and farrier charges. All expenses, including board, shall be payable monthly.
- 2. The mare shall be in a healthy and sound breeding condition: free from infections, contagious or transmittable diseases. A current coggins test, copy of registration papers (both sides), veterinarian health certificate, plus a health, worming and vaccination record is required. If the mare owner fails to provide any of the above documents, the mare owner hereby consents to the stallion managers veterinarian examining and/or testing the mare as may be necessary to complete the above tests, certification and other records. However, the stallion manager reserves the right to refuse any mare, which is (1) not in proper condition (2) which does not have all the records, tests, and registration documents as required herein.
- 3. Jarvis Anderson Performance Horses' staff agrees to diligently try to settle the owner's mare. The mare owner agrees to give Laughing Horse Ranch ample opportunity to settle the mare, having bred her through at least 2 heat cycles. If mare leaves the ranch before being pregnancy checked, the mare owner is required to have the mare ultra-sounded at 15 and 30 days after the last breeding date. If for any reason the mare does not settle, mare owner will hold Laughing Horse Ranch harmless.
- 4. **Transient Breeding or Semen Pickup** Booking fee will include first dose of semen for those mare owners who elect to pick semen up at Laughing Horse Ranch or bring their mare to the ranch for insemination on a collection day. The second and subsequent doses or inseminations will be charged \$50.00 each.
- 5. All unpaid board and all other expenses must be paid before mare departs the farm.
- 6. The Mare owner agrees to vaccinate the mare against rhinopneumonitis at least the 5th, 7th and 9th month of pregnancy.
- 7. The parties acknowledge that this agreement is made and shall be considered entirely performed in the state of Texas and shall be construed and enforced under the laws of the state of Montana. An equine professional is not liable for an injury or death of a participant in equine activities resulting from inherent risks of equine activities.
